In the case of interscholastic sports, we also give our consent for him to accompany the team on trips and will not hold the school responsible in case of accident or injury, whether it be enroute to or from another school or during practice or an athletic contest. We expressly agree and understand that we hereby release and **will not seek to hold the school responsible for negligence** in connection with any participation in sports at De Smet Jesuit High School, including physical education classes, intramural, club and interscholastic sports. We also hereby agree to hold the school, its employees, agents, representatives, coaches, and volunteers, harmless from any and all liability, actions, causes of action, debts, claims, or demands of every kind and nature whatsoever, **including, but not limited to, negligence**, which may arise by our child/ward in any activities related to the interscholastic or other sports programs of his school.

If we cannot be reached and in the event of an emergency, we also give consent for the school to obtain through a physician or hospital of its choice such medical care as is reasonably necessary for the welfare of the student if he is injured in the course of school athletic activities.

We acknowledge that the MSHSAA By-Laws provide and De Smet Jesuit High School requires that a student shall not be permitted to practice or complete for a school or participate in sports until it has verification of basic athletic insurance coverage. ATHLETIC ELIGIBILITY STANDARDS PLAYER'S CONTRACT

In addition to the Missouri State High School Activities Association rules which apply to interscholastic sports, De Smet Jesuit High School has established regulations for all athletes. Anyone who is found in violation of the following rules will receive the indicated sanctions. These standards are set for all school sports, but the individual violations do not carry over from sport to sport.

- A. SMOKING: Indefinite suspension from the team.
- B. ALCOHOL AND CONTROLLED SUBSTANCES: Indefinite suspension from the team.
- C. UNEXCUSED ABSENCE: For an unexcused absence a coach may demand:
 - 1. Extra supervised work
 - 2. Suspension from next game or contest
 - 3. Dismissal from the team
- D. WITHDRAWAL FROM TEAM: After becoming a member of a team for De Smet, a student may not drop from the team without the permission of the coach. Also, upon withdrawal the student will not be allowed to try out for another team during that sport season or begin practice with a team for the next sport's season.

We (parent/guardian and participant) have read and fully understand the Athletic Eligibility Standards and Rules as set up by MSHSAA (applicable to interscholastic sports) and De Smet Jesuit High School. We further agree to abide by these rules and understand the penalties that will be incurred for failure to do so.
